The seller has given ECTA a bridle easement to be approved by the seller, ECTA, Conservation Commission and developer.

Twelve Years on the Ipswich Planning Board

Leslie Brooks is currently the first vice president of ECTA. She served on the Ipswich Planning Board from 1990 through the end of 2002, and we have asked her to briefly share some thoughts about her years on the Board.

When I resigned from the Ipswich Planning Board at the end of 2002, it was with very mixed feelings. After over 12 years on the Board, most of them as Chairman, I felt ready to take a break from the year-round board meetings and subcommittee meetings and site visits, to say nothing of the occasional special meetings or requests to attend meetings of other town boards. But I also felt I was giving up the opportunity to make a difference in the town, and it was difficult to do that.

I was appointed to the Board in 1990, after having spent a year or so as the Planning Boardís representative to the Master Plan Commission, an ad hoc group formed to deal with what was viewed by some as the rampant growth in Ipswich in the mid-1980s. My concern from the beginning was the preservation of open space in town, and since I realized that it was impossible to prevent growth, my interest in serving on the Planning Board was an effort to at least have a voice in how and where it occurred.

Thatís not quite as simple as it sounds, though, since, although it often seems unfair and inappropriate, people do have the right to develop their land. Much as some or even all board members might like to just deny a particular project, there often are not adequate reasons for denial, and even

if there are, the Board is required to state the reasons and if the applicant is able to address them, the Board is then required to approve the project. Many neighbors who are involved in this process express frustration because they believe that the Board has the power to control aspects of development or to halt a proposed project and fails to use that power. But the reality is that the Boardís authority is more limited than some people believe and itís often difficult to make that understood.

Having said that, I can also say unequivocally that serving on the Planning Board was a very rewarding experience. Iím pleased to have been a part of the development of the Great Estates Bylaw and to have participated in numerous zoning changes that I believe are part of a positive direction for Ipswich. In my years on the Board, I met and worked with many talented and interesting people, and I developed a real appreciation for the work and creativity required to balance the needs of developers, town officials, and concerned citizens. There is always a need for people to get involved and work for the things they care about, whether itis trails and open space, schools, or the needs of the business community. At the risk of sounding preachy, I can say that for me, the satisfaction of being involved in the growth of Ipswich was well worth the time and effort that it took.

Nancy enjoys the trails right outside her door in Boxford, where she has lived since the mid 1960s. These days she traverses the woods on snowshoes, although she also rides her Palomino, Fred, both in Boxford and on the ECTA trails in



more suitable weather.

She recalls that BTA (Boxford Trails Association) got its start when one of her daughteris fellow 4-H members found a favorite riding trail closed. Nancy and the other 4-H mothers and some senior riders decided to take a stand and promote preservation and maintenance of

Whois Who in ECTA

Disa Cheston, Treasurer

Disa Cheston is ECTAís new Treasurer, replacing Amy Bresky, her West Newbury neighbor who now splits her time between Southern Pines and her longtime home here. Amy was quick to help Disa learn the ropes and responsibilities, as well as give her a quick course in Quick Books before heading south.

Disa has been active in ECTA and has seen many changes during the last 20 years that she has been riding on the trails. In addition to exercising field hunters for Susanna Colloredoís husband, Moose, she also enjoys the trails aboard her five-year-old prospective eventer, often teaming up with Susanna. The pair note conditions and changes, and locate new links. Sometimes Disa ventures into the woods on horseback to scout the trails for her husband Chip, who is responsible for all ECTA trail maintenance. He heeds the calls for clearing or making repairs, but sometimes cannot be sure that he can drive a truck back to where he has to work.

Trail clearing becomes a family affair when Disa, her two children, and Chip go out on remote trails to assess the work that needs to be done, or to cut back brush, clear fallen trees, and repair damaged trails together. Family lines run even deeper. Disaís mother-in-law, Lois, is an ECTA advisor and has long been active in ECTA (see the Winter 2002 issue of the ECTA News).

Disa and Chip grew up in the same neighborhood, with Bradley Palmer virtually in their backyard. Disa moved to Hamilton while still

attending high school, and began riding in the area and attended the local horse shows. When she recalls the early years of riding on the local trails, she notes that she has seen a lot of changes. While accessibility is often challenged, in Essex County a lot is still being maintained, she says. However, ithere are fewer barns, fewer kids riding, and now we're seeing trail association tags on bikes in Bradley Palmer. î

trails for passive recreation. In 1994 the organization became a land trust (BOLT stands for Boxford Open Land Trust), and has since helped preserve countless acres of land. Most recently BTA/ **BOLT** helped Boxford to purchase Wunnegen (the word for ibeautifuli in the Massachusett language of the Agawam Indians), formerly the Sawyer-Richardson property. BTA/ BOLT was also instrumental in getting the town to purchase Lockwood Forest, and helped oversee the growth of the Bald Hill Reservation and eventual connection of the 2000 acres to Georgetown-Rowley State Forest via the Bay Circuit Trail. BTA/ BOLT currently owns 170 acres of land, including Perkins Woods, 17 acres purchased three years ago as an important connecting trail to Cleveland Farm State Forest and Willowdale.

While she has held several positions in BTA/BOLT, Nancy has also been actively involved in the Bay Circuit program, which links trails around the outer Boston area.





For years she worked with the owners of the Lockwood Estate and ran the BTA/BOLT Horse Show and supported teh running of the ABC Benefit Horse Trials. She is still an advisor to both shows. The ABC Horse Trials benefits the organization A Better Chance at Masconomet Regional High School.

Nancy has been interested in conservation restrictions since working with landowners along Fish Brook to preserve the land surrounding the stream. Nancyís passion for land preservation leads her to remind all users of the trails to respect landowners and to be a member of the organization that protects the trails they are using.
